ORDINANCE 08-17

AN ORDINANCE PROHIBITING PARKING AT CERTAIN LOCATIONS IN THE VILLAGE AND ESTABLISHING A PRESCRIBED FINE.

WHEREAS, the Village of Lithopolis has adopted the Ohio Basic Code; and

WHEREAS, Chapter 76 of the Ohio Basic Code provides for parking regulations which the Lithopolis Police enforce in the Village; and

WHEREAS, Council finds that, due to the size and maneuverability characteristics of fire and other emergency vehicles, public safety in the Village would be enhanced, if on-street parking was at all times restricted to one side of the roadway in certain specific locations;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LITHOPOLIS, FAIRFIELD COUNTY, STATE OF OHIO;

Section 1. That Council hereby finds and determines that it is in the best interest of the safety and welfare of the Village to restrict parking in certain specific locations within the Village.

Section 2. That no person shall at any time stop, stand, or park a vehicle, except when necessary to avoid conflict with other traffic or while obeying the directions of a police officer or a traffic control device, in any of the following locations:

- a. The Northwest side of Crestview Drive from Rolling Acres Drive to Rolling Acres Drive.
- b. The Southeast side of Green Forest Drive from Rolling Acres Drive to Crestview Drive
- c. The Northeast side of Penny Drive from Westview Terrace to Abbey Avenue
- d. The North side of Westview Terrace from Penny Drive to Cherry Hill Court
- e. The East side of Cherry Hill Court
- f. The West side of Abby Avenue
- g. The Northwest side of Poe Avenue
- h. The Northwest side of Faulkner Drive
- i. The Northwest side of Salinger Drive from Orwell Street to Twain Ave
- j. The Northwest side of Salinger Drive from Twain Ave to Orwell Street

Section 3. That the Village Administrator is hereby directed to install and maintain in the areas of prohibited parking designated in Section 2 of this Ordinance "No Parking" signs in accordance with the design and installation requirements of the current version of the Ohio Manual of Uniform Traffic Control Devices.

Section 4. That any person charged with a violation of section 76.04, "Parking Prohibitions", of the Ohio Basic Code may, except as otherwise provided in the Ohio Basic Code, pay to the Village of Lithopolis a prescribed fine of \$50.00 in accordance with section 76.12, "Waiver", of the Ohio Basic Code.

Section 5. That this Ordinance shall take effect and be in full force at the earliest time permitted by law.
