Resolution 04-17

A RESOLUTION AUTHORIZING TEMPORARY STREET CLOSURES AND USE OF VILLAGE STREETS DURING MOVIE NIGHT, BLOOM TOWNSHIP FISH FRY, AND THE BIG DOG ENTERTAINMENT CAR SHOW.

WHEREAS, it is anticipated the 2017 Memorial Day Fish Fry, movie night, and the Big Dog Entertainment Car Show will draw a significant number of attendees and thus provide financial benefits to the Village; and thereby temporarily increase the pedestrian usage of the Village streets and sidewalks in excess of their normal use; and

WHEREAS, allowing the temporarily closure and use Columbus Street and Memorial Park for these events will encourage visitors to remain in the center of the Village during these events and improve public safety;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LITHOPOLIS, FAIRFIELD COUNTY, STATE OF OHIO;

Section 1. That Council finds, in order to provide for the health, safety, and general welfare of the Village during the 2017 Memorial Day Fish Fry, movie night, and the Big Dog Entertainment Car Show, it is necessary to encourage attendees to remain in the center of the Village and temporarily close certain sections of certain streets within the Village.

Section 2. That Council authorizes the Mayor to direct the Village Administrator to temporarily close, maintain as closed, and enforce as closed such sections of such Village streets as, in the Mayor's sole discretion, the Mayor finds necessary to provide for public safety during these events beginning no earlier than 3:00 p.m. on Sunday, May 28, 2017 and ending no later than 8:00 p.m. on Monday, May 29, 2017.

Section 3. That Council authorizes the Mayor to direct the Village Administrator to take the necessary actions to re-direct traffic to lessen the inconvenience to the traveling public during the period of temporary street closures authorized by Section 2 of this Resolution.

Section 4. That Council authorizes the Mayor to grant to the event organizers use of such portions of the streets in the Village of Lithopolis and Memorial Park as, in the Mayor's sole discretion, the Mayor finds appropriate to encourage attendees of these events to remain in the center of the Village, thereby providing for improved public safety during the events.

Section 5. That this Resolution shall take effect and be in full force at the earliest time permitted by law.
