**MINOR MISDEMEANOR TRAFFIC: \$129.00    MINOR MISDEMEANOR CRIMINAL: \$219.00**

**All Mayor's Court minor misdemeanorTRAFFIC fine totals are tabulated by adding a \$60 fine and \$69 court costs, for a total of \$129. If there is more than one minor misdemeanor traffic charge, court costs can only be assessed on one of the charges. The first charge would be \$129 and the second charge would be \$60, for a total of \$189.**

**All Mayor's Court minor misdemeanorCRIMINAL fine totals are tabulated by adding a \$150 fine and \$69 court costs, for a total of \$219. If there is more than one minor misdemeanor criminal charge, court costs can only be assessed on one of the charges. The first charge would be \$219 and the second charge would be \$150, for a total of \$369.**

**IN THE EVENT A PERSON IS CHARGED WITH A MINOR MISDEMEANOR TRAFFIC OFFENSE AND A MINOR MISDEMEANOR CRIMINAL OFFENSE, COURT COSTS ARE TO BE ASSESSED TO EACH INITIAL CHARGE. FOR EXAMPLE, IF A PERSON WAS CITED FOR SPEED(\$129.00) AND AN OPEN CONTAINER(\$219.00), THE TOTAL WOULD BE \$348.00. ANY ADDITIONAL MINOR MISDEMEANOR TRAFFIC CHARGES ARE \$60.00, AND ANY ADDITIONAL MINOR MISDEMEANOR CRIMINAL CHARGES ARE \$150.00.**
