

# Village of Lithopolis Drinking Water Consumer Confidence Report for 2014

## Introduction

The Village of Lithopolis has prepared the following report to provide information to you, the consumer, on the quality of our drinking water. Included with this report is general health information, water quality test results, information regarding how to participate in decisions concerning your drinking water, and water system contacts.

## Source Water Information

The Village of Lithopolis receives its drinking water from three wells. The wells are located at the water plant at 5664 Elder Road. In 2002 Ohio EPA completed a study of the Village of Lithopolis' source of drinking water to identify potential contaminant sources and provide guidance on protecting the drinking water source. According to this study, the aquifer (water-rich zone) that supplies water to the Village has a high susceptibility to contamination. This determination is based on the following:

1. The presence of a relatively thin protective layer of clay overlying the aquifer;
2. The shallow depth (less than 15 feet below ground surface) of the aquifer;
3. The presence of significant potential contaminant sources in the protection area.

There is currently no evidence to suggest that the Village's ground water has been impacted by any significant levels of chemical contaminants from human activities.

However, this susceptibility means that under currently existing conditions, the likelihood of the aquifer becoming contaminated is relatively high. OEPA has determined that this likelihood can be minimized by implementing appropriate protective measures. To minimize this risk, the Village of Lithopolis continues to participate in the Fairfield County Regional Drinking Water Source Protection Plan and has passed a Well Head Protection Ordinance which places restrictions on activities within the area of the production wells.

## What are sources of contamination to drinking water?

The sources of drinking water, both tap and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in sources of water include:

- (A) **MICROBIAL CONTAMINANTS**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife;
- (B) **INORGANIC CONTAMINANTS**, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming;
- (C) **PESTICIDES AND HERBICIDES**, which may come from a variety of sources such as agriculture, urban storm runoff and residential uses;
- (D) **ORGANIC CHEMICAL CONTAMINANTS**, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm runoff and septic systems;
- (E) **RADIOACTIVE CONTAMINANTS**, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, USEPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. In addition, FDA regulations establish limits for contaminants in bottled water which also must provide the same protection for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. ## Who needs to take special precautions?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as people with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk for infections. These people should seek advice about drinking water from their health care provider. ## About your drinking water

The EPA requires regular sampling to ensure drinking water safety. The Village of Lithopolis conducted sampling for bacteria, iron, hardness, manganese, sodium, nitrate, and nitrite during 2014. In the past two years, samples have been collected for a total of 50 different contaminants, most of which were not detected in the Village's water supply. The Ohio EPA requires the Village to monitor for some contaminants *less* than once per year because the concentrations of these contaminants do not change frequently. All of our data remains accurate, though some of it is more than one year old.

## Monitoring & Reporting Violations

EPA requires the Village to collect two coliform bacteria samples each month (twenty four samples each year) from the distribution system. In the past seven years we have had one sample that tested positive for coliform, due to a contaminated softener at the site where the sample was drawn. During the months of July 2014, and February 2015, the Village failed to sample for coliform. During 2014 the Village also failed to submit one of the two required samples for Total Trihalomethanes (TTHM) and Haloacetic Acids Five (HAA5). As noted in the chart below, the other sample submitted from the distribution system indicated no violation of EPA limits of these contaminants.

Listed below is information on those contaminants that were detected in the Village of Lithopolis' drinking water.

In 2014 the Village tested for other inorganics including: antimony, arsenic, beryllium, cadmium, chromium, cyanide, mercury, nickel, nitrite, nitrate, selenium, and thallium. All were below detectable limits.

#### ***Volatile Organic Chemicals***

In 2014 the Village tested for 22 Volatile Organic Chemicals. All were below detectable limits.

#### ***Synthetic Organics***

The Village tested for Alachlor, Atrazine, and Simazine in 2014: all test results were below reporting limits.

### **Lead Education Information**

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The Village of Lithopolis is responsible for providing high quality drinking water, but cannot control the variety of materials used in residential plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. ### **License to Operate (LTO) Status Information**

In 2014 we had an unconditioned license to operate our water system.

### **Public Notice**

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During 2014, we did not complete one of two required tests for Total Trihalomethanes (TTHM) and Haloacetic Acids. During the month of July 2014 and February 2015 the Village failed to monitor for total coliform bacteria, and therefore cannot be sure of the quality of your drinking water during that time.

### **How do I participate in decisions concerning my drinking water?**

Public participation and comment are encouraged at regular meetings of the Lithopolis Village Council which meets the second and fourth Tuesday of each month at 7:30 o'clock P.M. in the Municipal Building, located at 11820 Lithopolis Road.

#### **Definitions of terms contained within this report**

**MAXIMUM CONTAMINANT LEVEL GOAL (MCLG):** The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

**MAXIMUM CONTAMINANT LEVEL (MCL):** The highest level that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**MAXIMUM RESIDUAL DISINFECTANT LEVEL (MRDL):** The highest residual disinfectant level allowed. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

**MAXIMUM RESIDUAL DISINFECTANT GOAL (MRDLG):** The level of residual disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

**PARTS PER MILLION (ppm) or MILLIGRAMS PER LITER (mg/L):** Are units of measure for concentration of a contaminant. A part per million corresponds to one second in a little over 11.5 days.

**PARTS PER BILLION (ppb) or MICROGRAMS PER LITER (ug/L):** Are units of measure for concentration of a contaminant. A part per billion corresponds to one second in 31.7 years.

**ACTION LEVEL (AL):** The concentration of a contaminant which, when exceeded, triggers treatment or other requirements which a water system must follow.

**THE "<"SYMBOL:** A symbol which means less than. A result of <5 means that the lowest level that could be detected was 5, and the contaminant in that sample was not detected.
