### **Officers Report:**

**Village Administrator** – Amanda shares with council a portion of the letter received from the EPA regarding the Sanitary Inspection performed earlier this year. The letter states No Violations were found. Amanda also informs council that FeeCorp cleaned the storm drains on South St. in much less time than it has taken in the past. Amanda attributes this to the maintenance being done on a regular basis throughout the year. Columbus Street will also be done.

**Fiscal Officer** – A Reading of Ordinance 19-23 Supplemental Appropriations Budget takes place. A Motion to approve Ordinance 19-23 by Tennant 2<sup>nd</sup> by Long Ayes: 5 Nays: 0

**Chief** - Approved an applicant for hire contingent on passing the physical. Has an interview on Friday for another officer. It's important to have full staff to handle the upcoming Memorial Day events. Shares information on Marcie's Law Program.
