Mayor Sandine shares the 2024 Capital Improvement Plan with council. A discussion takes place regarding key points of the plan.

The Mayor shares that the village has been approved for a loan through the EPA for the water and sewer extension to Jackson Lake. While the village will obtain the loan, Jackson Lake will be repaying the loan. Details of an agreement between Jackson Lake and the Village are still being negotiated.

The Mayor shares the Insurance quote from Wichert Insurance. He explains that we have a new agent however, the same company. All Insurance is covered with Selective Insurance instead of multiple companies as in past years.

The Mayor asks council to reschedule a few upcoming meetings due to conflictions with regular scheduled dates. Council agrees to reschedule the following meetings, February 13<sup>th</sup> to February 12<sup>th</sup>, February 27<sup>th</sup> to February 28<sup>th</sup> and March 12<sup>th</sup> to March 11<sup>th</sup>.

#### **Officers Report:**

Chief – Chief Barton shares the Police Blotter for November 2023 and December 2023. He shares that he continues to interview applicants for another full-time police officer. Mayor Sandine asks the chief to share information about the Flock System. A discussion takes place regarding the benefits Flock would bring to the village. Tennant asks if there are grants available to purchase the system. Sandine shares that since the efforts to increase revenue for 24/7 police coverage through a tax increase failed, the village will be exploring other ways to ensure the safety of the residents.

**Village Administrator** – Amanda shares a 2023 End of Year Report. A discussion takes place regarding the water leak at Elder Rd. and St Rt 674. Amanda shares that the utility clerk, Diana Contino, has moved on. The village is currently working to fill the position. Amanda thanks Eric, Simon, Hunter, Robbie, Rivka and Council for all of their help and support. The Mayor indicates he is very pleased with the village team. Amanda, Simon and Hunter completed the Stormwater Pollution Prevention Training. S. Greene suggests putting some of the tasks Amanda shared in her report on Social Media to make residents aware of what is necessary to keep the village running and the "behind the scenes" work that is done.
